This was not actually sent to Sweden but was a letter from Norway to Hamburg for his studies. Many letters from Norway, particularly if sent via Sweden when there are no Swedish postal markings for letters to Hamburg. Your letter was sent via Sweden to Hamburg by the "de Helsingberg" company.

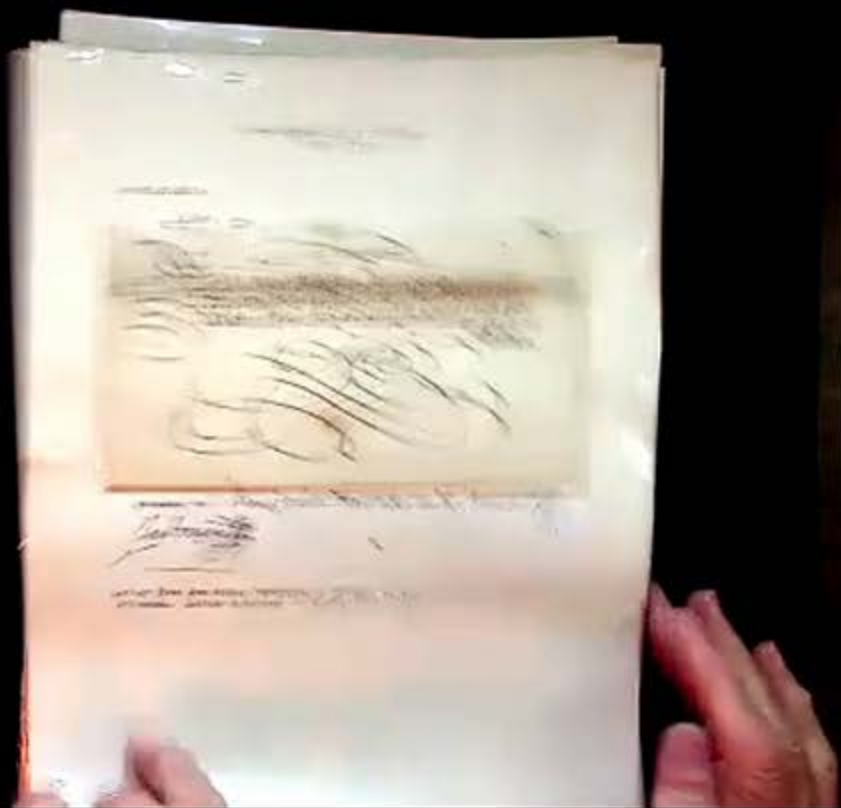
Your letter is in the category of so-called markings for postage to Hamburg. The earliest one "20" is a French marking as is the "10". Postage for a letter less than 4 grams from Stockholm to Denmark from October 1, 1821, to July 1849, was 20 denars. The postage was 20 denars for a letter between 4 and 8 grams. I suspect that your letter was originally marked as 7 grams and as the "20" denars marking. It was then marked as 4 grams and the postage was reduced to 10 denars. Thus there are no postal rate markings for correspondence to Hamburg. The "20" appears to be a fee marker as it has a dash after it.

I do have a postal rate list for the period of your letter when there was a rate listed for each quarter of the year. The single-letter rate for the 3rd quarter of 1823 was 16 sk. I appreciate your compliment on my book, but I do not discuss it for assistance on letters from Norway.

An interesting feature of the combined T&T and French involvement between Hamburg and France was that the weight progression was the French weight progression for the metric system. T&T used a more general weight progression when France was not involved but apparently was only too glad to take advantage of the increased revenue provided by the French progression.
